Project Plan: Land Matters Project

The purpose of this project is to review Prince Edward Island's policy and legislative framework for land and propose changes where necessary **Purpose:**

to reflect present-day and future priorities. The process will be guided by inclusive and purposeful public engagement exercises and a strong

foundation of evidence.

Rationale: This project is being initiated in response to recent public discussions, the findings of past land reports, and current government mandates to

review and update the Lands Protection Act and Planning Act. A range of factors that matter to Islanders have been identified. For example: Indigenous perspectives; land use, protection, planning, ownership limits and transparency; agriculture, coastal, forested, and environmentally sensitive land; special planning areas; and non-resident ownership are some but not all of the factors the project will explore. These identified

factors provide the project with a foundation to begin discussions.

This project will utilize existing knowledge and input from Islanders and will move through purposeful engagement exercises to arrive at **Process:**

actionable and evidence-informed policy, legislative, and regulatory change. Notwithstanding the process below, Government may make

policy and/or legislative amendments to address immediate needs or concerns.
